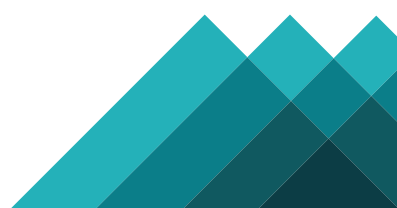

Preface

This document was updated following the announcement of new Vision Realization Programs (VRPs), to support achieving Saudi Arabia's Vision 2030 ambitions and objectives. Some of the initiatives in the previous National Transformation Program (NTP) delivery plan document are now included in the delivery plans of the relevant VRPs.

April 25, 2016

Launch of the Kingdom's Vision 2030

The Kingdom's "Vision 2030" comprises 96 strategic objectives, governed by a number of Key Performance Indicators (KPIs), that will be achieved through a number of initiatives codeveloped and executed by different governmental entities alongside private and non profit organizations within the respective ecosystems. The Council of Economic and Development Affairs has set up an effective and integrated governance model with the aim of translating "Vision 2030" into multiple VRPs working in parallel to achieve the strategic objectives & realize the vision.

June 06, 2016

Launch of the National Transformation Program

In order to build the capacity and capabilities required to achieve the ambitious goals of "Vision 2030," the National Transformation Program was launched as a VRP involving 24 government agencies. It aims to develop governmental work and establish the needed infrastructure to achieve "Vision 2030" ambition and requirements.

Updating the Program's 2018-2020 Delivery Plan

In line with the launch of new "Vision 2030" VRPs; changes to the first version of the National Transformation Program had to take place. These changes required the adaptation, integration, and re-arrangement of many initiatives established under the first version of the NTP delivery plan into the relevant VRPs delivery plans.

The aim of this update is to define the NTP scope, roles and responsibilities, and the related Vision 2030 strategic objectives that are focusing on the following three principles:

1. Achieving Governmental Operational Excellence
2. Improving Economic Enablers
3. Enhancing the Standards of Living

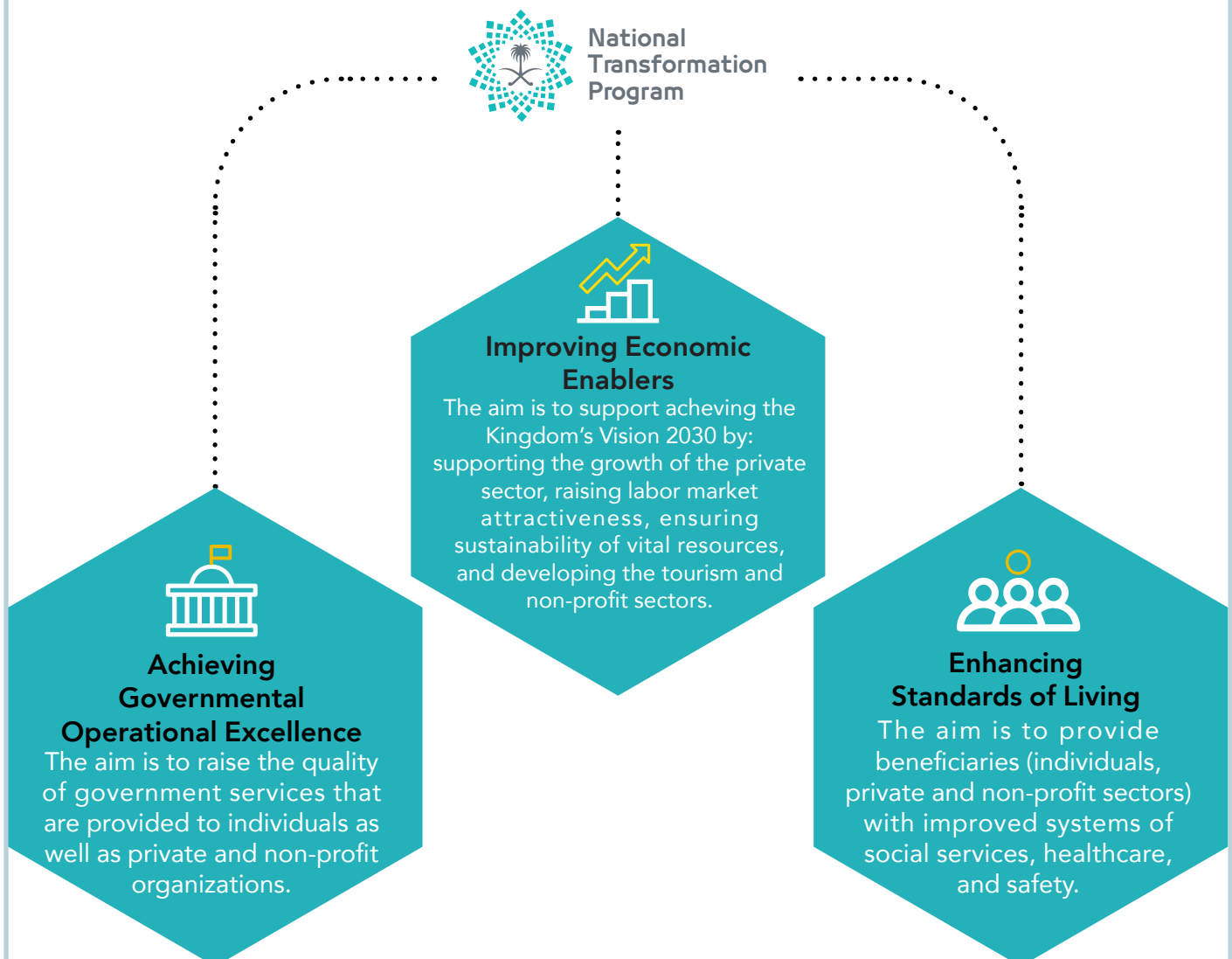

| First Theme: Transform Healthcare

Summary

The First Theme (Transform Healthcare) seeks to achieve a vibrant society by restructuring the health sector to become a comprehensive and effective system. It will promote public health through the implementation of a new model of care that focuses on prevention and improving society's health awareness. It will also improve access to health services through optimal coverage, equitable geographical distribution, as well as comprehensive and expanded e-health services and digital solutions. Furthermore, it will aim to continually improve health services by focusing on beneficiary experience and satisfaction in line with international standards and best practices.

National Transformation Program Strategy

(Theme 1: Transform Healthcare)

In order to overcome the above mentioned challenges, the following strategic objectives were developed:

I First Theme's Strategic Objectives

- **Strategic Objective (2.1.1: Ease Access to Health Services):**
Enhance the accessibility of healthcare services for citizens and residents at the right time and right place, through four components: expansion of total capacity (number of beds and medical staff), adequate geographical distribution (distance from healthcare provider), timely and affordable access to related healthcare services.
- **Strategic Objective (2.1.2: Improve Quality and Efficiency of Healthcare Services):**
Enhance the overall value provided to beneficiaries through the improvement of the quality and efficiency of the healthcare services as well as the safety of the healthcare facilities; ensuring adequate healthcare coverage with financial sustainability.
- **Strategic Objective (2.1.3: Promote Prevention Against Health Risks):**
Enable healthy living by promoting preventive healthcare (such as awareness and vaccination) to minimize the risks associated with health crises and diseases of communicable and non-communicable diseases.

Initiative Name	Initiative Description
Corporatization of Healthcare Facilities	The initiative is concerned with the separation of healthcare services from the Ministry of Health, and transferring those services to Accountable Care Organizations (ACOs) that compete on the basis of quality, efficiency, and productivity.
E-Health	The initiative aims to improve the efficiency of the healthcare sector through information technology, digital transformation, and through utilizing state of the art technologies to ease access to healthcare (such as tele-medicine, and tele-consultations).
New Model of Care	The initiative aims to introduce a new approach to healthcare that focuses on prevention and goes beyond simply disease treatment; it will integrate the role of the individual, society, and institutions with the role of health service providers to ensure access to healthcare in accordance with best practices.
Health Insurance Program and Purchase of Health Services	The initiative aims to supervise the purchase of healthcare services, which includes a package of comprehensive health benefits approved by the concerned authorities. These services cover all citizens and residents working in the government sector and their families.
National Project for the Planning and Development of Health Graduate Programs	The initiative aims to develop programs that increase the number spaces available for training and improves the quality of the training outputs, in order to contribute to the qualification of specialized health professionals in the Kingdom of Saudi Arabia.
Ensure Compliance with Safety Standards in Health Facilities and Conduct Emergency Repairs	The initiative is concerned with the development of healthcare facilities to comply with safety standards, as well as the training of the workforce.
National Health Information Center - Cross Cutting e-Health Initiatives	The initiative aims to provide an electronic service focused on working with all sectors providing healthcare services and other related sectors, in order to construct a more coherent system; more integrated health services will enable the beneficiaries to easily access medical services of high quality and security.

Initiative Name

Initiative Description

Increasing the Contributions from Charity to Healthcare

The initiative aims to increase the level and quality of charity giving in the healthcare sector so that the community can effectively contribute to financing and delivery of health services in the areas and regions most in need. This is accomplished through the creation of an enabling and encouraging legislative environment, flexible financial channels, and a variety of participatory tools, so that all social components contribute to overcoming the health challenges facing the Kingdom.

Corporatization of King Faisal Specialist Hospital & Research Centre

The initiative aims to establish a private company owned by the General Establishment of King Faisal Specialist Hospital and Research Center. This initiative enables the organization to achieve operational transformation and partnership with the private sector.

Establishing and Preparing Primary Healthcare Centers to Meet National Standards of Quality and Patient Safety (CBAHI)

The initiative aims to establish and equip primary healthcare centers to meet national standards for quality and patient safety requirements by providing the necessary construction requirements for basic safety, and by providing the necessary medical equipment in various departments.

Establishment of the National Center for Training and Evaluation of Healthcare Graduate Programs

The initiative aims to increase the effectiveness of healthcare training in post-graduate programs by establishing a national specialized center to train trainers and trainees for all healthcare graduate programs by all possible means in order to increase the quality of training outputs.

Technology Assessment Center

The initiative aims to establish a National Center for the assessment of healthcare technologies, which can then be classified as preventive, diagnostic, therapeutic, rehabilitative and palliative.

Saudi Center for Patient Safety

The initiative aims to establish and launch the National Center for Patient Safety to promote a national culture of patient safety reporting and to raise awareness of safety issues.

Healthcare Sector Governance

The initiative aims to design and roll out a new structured and integrated ecosystem intended to improve transparency and accountability through clear delineation of roles and responsibilities among various parties.

Auditing Private Sector Applications

The initiative aims to oversee the contracts with medical referral companies so that healthcare services purchased on behalf of the Ministry of Health, are based on accepted standards.

Partnership Between Public and Private Sectors

The initiative aims to establish partnerships with the private sector to finance capital and operational projects to increase capacity and efficiency, and reduce waiting time and capital expenditures.

Participation with the Private Sector (King Faisal Specialist Hospital)

The initiative aims to enable the transformation of King Faisal Specialist Hospital to undertake initiatives to engage with private sector, such as marketing and partnership to generate income.

Operational Transformation at King Faisal Specialist Hospital and Research Center

The initiative aims to enhance the operational services including clinical, financial, electronic, and human resources services to achieve the level of performance required of independent non-profit organizations.

Development of Blood Transfusion Services

The initiative aims to raise the level of blood transfusion making blood donation sufficiently attractive to reach a 100% voluntary donation rate.

National Health Innovation Center

The initiative aims to establish a national center to encourage and foster creativity and innovation in healthcare.

Patient Experience Center

The initiative aims to establish a National Center for Patient Experience in healthcare facilities, covering all aspects of different healthcare pathways.

Enhancing Skills of Emergency Medical Care Providers

The initiative aims to develop and improve the skills and knowledge required for emergency service providers.

Promote Patient-Centered Care through Accountability and Transparency

The initiative aims to develop a patient-centered healthcare culture and increase participation by providing data, using technology and engaging patients in decision-making to achieve excellence in healthcare services provided to them.

Initiative Description

Establish an Electronic Tracking System

The initiative aims to establish an e-tracking system for pharmaceuticals so that their distribution can be tracked to ensure their safety and availability within the market.

Establish Halal Center

The initiative aims to establish a global center for food and various Halal products to grant Halal certificates and accreditation.

Technology Development Center of Health Information Systems

The initiative aims to establish a center of excellence that develops health information systems which can be used in healthcare education sector.

Initiatives to Implement the Kingdom's Healthcare Strategy

The initiative aims to review and adjust existing health policies and regulations in line with the strategy of new healthcare system.

Support Scholarship Program in the Ministry of Health

The initiative aims to support the logistic of scholarship program to ensure the quality of the output quality of existing program between the Ministries of Education and Health.

Organ Donation and Transplant Programs National Awareness Campaign

The initiative aims to manage and facilitate organ donation and transplant in coordination with the concerned authorities.

Privatization of King Faisal Specialist Hospital

The initiative aims to transform King Faisal Specialist Hospital and Research Center into an independent non-profit entity by modifying existing legal system and evaluating the organization's readiness to transform.

Promoting Organs Donation Programs in Intensive Care Units

The initiative is to coordinate with the concerned authorities in intensive care units to manage and facilitate organ donation and transplant.

Initiative Description

Community Participation

The initiative aims to review and develop rules and regulations related to donations and endowments in the field of healthcare in order to provide a motivating and flexible legislative environment for the community to contribute to the financing of health services.

Special Diseases Accreditation Program

The initiative aims to enable the "Aman" program which is intended to ensure meeting the national requirements of patient safety. In addition, it will expand the national accreditation program to include besides the hospitals the remaining healthcare facilities in the kingdom.

Strategic Healthcare Initiatives in KSA (Quality and Safety Development in Health Sectors)

The initiative aims to implement the regulations and principles of quality management and patient safety based on globally proven mechanisms, in addition to spreading the culture of quality within healthcare institutions.

Initiatives to Implement the Kingdom's Healthcare Strategy (Maximizing Utilization of High-Cost Apparatuses and Equipment)

The initiative aims to implement a national program that measures the distribution of medical equipment in the Kingdom's healthcare institutions, as well as to assess how well they are utilized.

Interactive Laboratory

The initiative aims to establish a virtual training center accredited by international standards for the training of healthcare personnel in intensive care; it will also standardize and improve the performance of healthcare practitioners assigned with organ failure, organ donation, and transplant programs.

National Program for Monitoring Healthcare Quality Indicators

The initiative aims to create an information technology infrastructure that can support a data center capable of monitoring, collecting, and analyzing all indicators in all healthcare facilities in the Kingdom.

Establish the Standard Electronic System

The initiative aims to develop and standardize registration, licensing, inspection, clearance, export, and enforcement procedures for investors in the SFDA in all sectors.

Healthcare Sector Transparency Initiative

The initiative aims to develop mechanisms and regulations to ensure greater transparency in healthcare sector in both pricing and quality of services. The initiative includes all public, private, and non-profit service providers, with the participation of the Strategic Studies Center in the Ministry of Economy and Planning.

Initiative Name

Initiative Description

National Program for Evaluating Organ Transplant Centers

The initiative aims to grant licenses for Organ Transplant Centers, evaluate their performance, and ensure the quality of healthcare services provided through specialized national committees that study and analyze these centers' outcomes.

Easing the Purchase of Chemical Substances and Laboratory Equipment

The initiative aims to amend the procedures for requesting and purchasing chemical substances and laboratory equipment to ensure the continuity of work and to produce results with the required efficiency and quality.

Improve Intensive Care and Emergency Rooms to Ensure Adequacy, Quality and Speed of these Services

The initiative aims to increase the availability, equipping, and operation of additional ICU and ER beds throughout the facilities of the Ministry of Health, in addition to introducing further improvements in systems, operations, and staff development.

Reform and Restructure Primary Healthcare Services

The initiative aims to provide better healthcare facilities through establishment and development of primary healthcare infrastructure, as well as improve accessibility access to healthcare in remote and peripheral areas through Mobile Clinics Program.

Expand Extended Healthcare Services

The initiative aims to provide long-term healthcare services -including medical rehabilitation, long-term care, psychiatric centers, and home healthcare- through the purchase of services from the private sector.

Enhance Emergency Medical Services

The initiative aims to improve emergency response time and readiness by increasing the number of teams and emergency centers.

Improve Access to Existing Government Health Facilities and Integrated Capacity Planning

The initiative aims to design a system that ensures patients' ability to access healthcare facilities, especially with regard to heart disease and critical care.

Improve Performance of Hospitals and Specialized Medical Centers in the Ministry of Health

The initiative aims to improve the performance and clinical aspects of hospitals, specialized centers, and medical rehabilitation centers according to regional and international standards.

Initiative Name

Initiative Description

Expand the Coverage of Specialized Services

The initiative aims to support specialized centers and services through purchasing of equipments, training and enabling the workforce of doctors and health practitioners.

Saudi Center for Appointments and Medical Referrals

The initiative aims to manage medical referrals and the procedures of booking appointments for all patients transferred between health facilities inside and outside the Kingdom, through standard work procedures and through the design of a unified e-system for referrals and appointments.

Workforce Capacity Planning in Healthcare Sector

The initiative aims to identify the resource requirements for the health sector in the Kingdom. This includes manpower, services and facilities, using methodological planning mechanisms, and scientific prediction tools based on inputs that contribute mainly to shaping the future image of healthcare.

Improve the Performance of Primary Healthcare Centers in the Ministry of Health

The initiative aims to improve the quality of primary care services in order to:

- 1- Decrease inappropriate hospital referrals
- 2- Increase the number of patients enrolled in health centers within the service
- 3- Increase vaccination coverage
- 4- Ensure diagnosis and treatment per evidence-based medicine
- 5- Increase patient satisfaction
- 6- Increase staff satisfaction

Expand Healthcare Facilities to Include Clinics for Growth and Behavioral Disorders, and Psychiatric Clinics.

The initiative aims to establish psychiatric centers within hospitals which have a capacity of more than 100 beds. Moreover, basic psychiatric clinical services will be provided in hospitals which have a capacity of less than 100 beds.

Provide Specialized Medical Laboratory Services

The initiative aims to enhance the services of King Fahd Center for Medical Research, the most important of which is the provision of specialized diagnostic and laboratory services, which are not locally available.

Enhance Response Time to Emergency Calls

The initiative aims to increase the operational capacity and readiness of the Saudi Red Crescent Authority by linking its technical systems with other health sectors, improving integration and coordination.

Community Participation Strategy to Promote Certain Health Professions

The initiative aims to launch a national project that will increase the attractiveness and value of supporting healthcare professions/service to the community.

Establishment and Activation of Nutrition Clinics

The initiative aims to facilitate community access to nutrition health services across the country to reduce malnutrition and nutrition-related diseases (such as obesity and diabetes).

Medical Services in the Faculty of Dentistry

The initiative aims to invest in dental clinics to serve local community.

Initiatives to Implement the Kingdom's Healthcare Strategy (Balanced Distribution of Health Services and Facilities)

The initiative is concerned with the current status of the distribution of facilities and services, and seeks to develop a national plan that improves ease of access to services.

Initiatives for the Implementation of the Kingdom's Healthcare Strategy (National Health Referral Plan)

The initiative is concerned with the revision of referral systems among health facilities in all sectors to design systems that are compatible with sector priorities.

National Center for Disease Control and Prevention

The initiative aims to activate the Center's functions and contribute to the reduction and monitoring of communicable and non-communicable diseases and to prevent their spread, as well as to promote health, research, and studies in the prevention and control of communicable and non-communicable diseases.

Providing Psychiatry Consultations through Primary Healthcare Centers

The initiative aims to equip Primary Healthcare Centers (PHC) with the necessary resources to provide basic psychiatry services mainly through establishing psychiatry clinics and training PHC personnel to diagnose and handle most common psychiatric diseases such as depression and anxiety.

Health Research Center

The initiative aims to establish a National Health Research Center to develop health policies and improve the level of public health and health services, based on the recommendations of scientific research.

Initiative Name

Initiative Description

Emergency Health Readiness

The initiative aims at activating a National Center for Emergency and Health Disaster Management as well as supporting regional centers.

"HESN" Program

The initiative aims to improve public health outcomes and provide an adequate and integrated database that will help to take preventive measures to prevent the outbreak of diseases and epidemics.

National Horizontal Health Records

The initiative aims to establish health records that collect detailed data on procedures for the treatment of predetermined diseases and health conditions by identifying a set of key data for these diseases and collecting them nationally from all healthcare providers.

National Register of Organ Failure

The initiative aims to use a specialized e-system to register patients with organ failure and organ donors, and develop the necessary procedures for follow up.

Interactive Awareness Programs

Furthermore, the theme aims to make Saudi Arabia attractive to international talent by opening more public and private schools, as well as adopting an efficient and simplified system for issuing visas and residence permits.

The aim of this initiative is to identify and establish a network for the prevention and handling of traffic accident injuries in accordance with international standards.

The aim of this initiative is to build an integrated information system to monitor the causes of accidents and to alert road users to traffic conditions and surrounding conditions (weather conditions, work areas, and hazards), helping them make timely decisions through digital signage, mobile messages, and other modern technologies.

Ensure Vehicle Compatibility with Traffic Safety Norms and Standards

The aim of this initiative is to modernize the inspection system for vehicles, assess the needs of inspection stations, improve the operating efficiency and maintenance of truck weighing stations, and develop regulations for vehicles for the transport of groups, goods, and hazardous material.

Training, Licensing and Monitoring of Drivers to Improve Driving Behaviors

The aim of this initiative is to monitor and improve driving by separating the education and test responsibilities, updating the traffic safety education curriculum, providing driving schools, identifying dangerous driver conduct, activating the points system, developing special training programs for unsafe drivers, and updating the standards for medical examinations necessary for driving license renewal.

Prepare Tools and Materials to Teach Students about Traffic Safety

The aim of this initiative is to measure the current traffic awareness among students, and after identifying the needs, prepare educational materials with traffic safety concepts and applications.

The aim of this initiative is to review the list of violations affecting traffic safety that have a direct or indirect impact on public safety, with a view to modifying and developing them, and adopting more effective media communication programs to inform the public of changes in the system.

The objective of this initiative is to develop regulations for road paving items and materials to ensure that contractors and suppliers comply with the specifications and standards of paving materials and road signs through working with private laboratories.

Develop a Comprehensive Pre-Hospital Care System

The aim of this initiative is to unify the emergency system and develop services that can ensure access to sites where an injury may have occurred; offer first responder training to traffic police and civil defence personnel; and develop national standards for the accreditation of ambulances and first-responders.

Road Safety Initiative to Reduce Road Traffic Deaths

The aim of this initiative is to improve the level of road safety through strategic programs and projects to link government institutions with a centralized leadership on road safety, as well as upgrade road infrastructure projects.

Rehabilitate Contaminated Areas

The aim of this initiative is to develop an integrated program that includes studies to determine the optimal solution for the rehabilitation of contaminated areas. Further, it aims to develop a mechanism to monitor the progress of execution with the responsible entities, and ensure the use of the environmental standards and controls.

Establish a Center for Environmental Information, Meteorology, and Early Warning of Weather and Pollution

The aim of this initiative is to establish a national information center that will provide environmental information and indicators to increase the accuracy and speed of the delivery of emergency information to the concerned parties. Further, this initiative aims to ensure monitoring natural and environmental disasters to protect citizens and their property.

The objective of this initiative is to expand the national network of air pollution control on a Kingdom wide basis, increase its comprehensiveness, activate the necessary legislation, update the standards, implement the system of observance of violations, and prepare a national emergency plan to deal with critical air pollution cases.

Protect the Marine and Coastal Environment

The aim of this initiative is to increase the level of environmental control in coastal areas and the marine environment through an integrated system that enables the protection and utilization of coastal and marine areas, while achieving environmental compliance.

Develop an Environmental Inspection Program

The aim of this initiative is to provide an integrated system to conduct environmental inspection of industrial establishments, with the aim of reducing pollution across the country.

Establish a National Environmental Groundwater Monitoring Program

The aim of this initiative is to establish and develop an integrated system for monitoring the quality of groundwater and surface water to ensure compliance with environmental standards and controls, as well as to reduce pollutants to protect the Kingdom's water resources.

This initiative aims to establish and develop an integrated national program to raise the awareness of environmental issues, promote individual responsibility, encourage voluntary efforts, and rationalize the use of natural resources.

This initiative aims to localize the methodology of the strategic environmental assessment for developing policies, plans, and initiatives.

The Transformation of Meteorological Services and Diversification of Funding Sources

This initiative aims to partner with the private sector to provide new and upgrade existing meteorological services through the establishment of a national company; it also calls for establishing an Environmental Protection Fund.

A National Program to Monitor Audio and Visual Pollution in Major Cities

This initiative aims to measure the level of noise and light pollution, and then determine their negative impacts within cities.

The objective of this initiative is to implement the proper management of chemicals for the protection of human health and the environment, while ensuring the sustainability and development of activities related to the uses and trade of chemicals.

The aim of this initiative is to develop and implement a system for monitoring the sources of sewage, as well as industrial and cooling water, linked to the Environmental Control Center; it will also ensure protection of various aquatic environments from sewage pollutants and reduce environmental degradation.

The aim of this initiative is to increase the quality of the environmental services provided by restructuring the accreditation mechanisms of companies in the sector providing those services, and reducing the time period for obtaining the environmental license for projects and industrial activities.

The objective of this initiative is to promote the proper management of municipal solid waste, to update legislation and standards related thereto, to strengthen the control process, to promote waste recycling, and to reduce waste incineration and incinerator pile emissions.

Activate the Integrated Management of Industrial and Hazardous Waste

The aim of this initiative is to prepare and implement an integrated management plan for industrial and hazardous waste, reduce the volume of industrial and hazardous waste produced, and localize recycling technologies and associated energy production.

Environmental Periodic Inspection for Fuel Stations and Service Centers

The aim of this initiative is to reduce leaks from fuel stations and vehicle service centers to result on reducing their impact on groundwater and soil.

Summary

The third theme (Ensure Sustainability of Vital Resources) aims to develop and protect natural areas such as, reserves, islands and beaches. It also aims to formulate the optimum environment to attract the private sector and activate its roles to rehabilitate and maintain these natural areas. The theme also aims to improve the Kingdom's environmental protection from natural hazards via vegetation to both; combat desertification and protect against insects and pests. Further, the theme aims to improve the national capabilities to predict natural hazards and reduce the response time to protect against human, economic and environmental impacts. Moreover, the theme also intends to develop the Kingdom's biological resources and ensure its sustainability through focusing on; water resources, food and drugs security and availability of labor. This would strengthen the national capability of effective crisis management.

Establish a Climate Change Center

The aim of this initiative is to implement the National Strategy for Adaptation to Climate Change by establishing a Center for Climate Change. The center will also ensure the management of climate data and information along with their impact on the the Kingdom's various sectors.

Expand Natural Reserves and their Integrated Management

The aim of this initiative is to develop integrated management and operation plans to improve the economic, environmental and social performance of the Kingdom's reserves. The plans will be customized for each of the Kingdom's regions independently with an electronic mechanism to declare new reserves.

Develop the System of Trading in Fungal Organisms, their Products and their Integrated Management

The objective of this initiative is to develop an ecosystem to trade fungal organisms and their products, which includes licensing, inspection and setting control measures.

Develop Wildlife Research Centers

This initiative aims to develop and rehabilitate the Prince Saud Al-Faisal Wildlife Research Center, the King Khalid Wildlife Research Center, and the Prince Mohammed Al Sudairy Center, to preserve biodiversity and conduct related research.

Facilitate and Attract Biodiversity-Based Investments

This initiative aims to provide the optimum environment for the private sector to invest in the wildlife sector by organizing and licensing investments in reserved areas, zoos and water museums.

Develop a Framework to Regulate Hunting Activities

The aim of this initiative is to regulate hunting activities of wild animals and birds through the development of licensing mechanisms. In addition to cooperating with the concerned authorities to improve the control mechanisms and impose disciplinary actions.

Animal Disease Investigation and Control Program

The aim of this initiative is to develop an integrated program to investigate and control critical animal diseases through continuous monitoring of the diseases and their related factors.

Develop an Effective Food Strategic-Reserve Program that Includes an Early Warning and Information System for Agricultural Markets

The aim of this initiative is to develop an emergency management system and protocols to respond to food security emergencies in the Kingdom. Additionally, it aims to build a state-of-the-art early warning system to forecast all related threats.

Strengthen Applied Agricultural Research

The aim of this initiative is to enhance the productivity of the Kingdom's fish resources on the basis of applied scientific research in cooperation with renowned research institutions both locally and internationally. In addition to incorporating economical improvements to the industry in the Kingdom for both waste minimization and productivity enhancement.

Rehabilitate Agricultural Terraces and Apply Rainwater Harvesting Techniques in the Kingdom's Southwestern Region

The aim of this initiative is to rehabilitate the agricultural terraces in Taif, Al Baha, 'Asir, and Jazan via rainwater harvesting techniques to increase the productivity of strategic crops and contribute to the food security and rural development.

Develop Fishing Harbors

The aim of this initiative is to create investment and tourism opportunities through developing fishing ports and the countryside. In addition to providing economical and professional support to the countryside communities in partnership with the private sector.

Support and Improve the Performance of Agricultural Cooperative Societies

The aim of this initiative is to improve the agricultural cooperative societies through mergers with strategic agricultural companies to capitalize on the local and private sectors, as well as donor institutions.

A National Program to Reduce Food Loss and Waste Based on Standards, Global Experiences and Best Practices

The aim of this initiative is to promote the development of harvesting techniques and food production infrastructure through performing an assessment for quantifying the Kingdom's wasted food.

Transform the Delivery of Agricultural Services

This initiative aims to establish a state-owned service company that provides agricultural services on sustainable basis. In addition to increasing the efficiency of the assets and resources of the Ministry of Environment, Water, and Agriculture.

Strategic Storage of Drugs, Serums and Vaccines

The objectives of this initiative are to ensure the sustainability of essential and emergency medicines in hospitals for a limited period, and to determine the minimum quantities of serums, vaccines, and essential medicines for critical diseases.

This initiative aims at establishing a database of all agricultural holdings and activities under the umbrella of the Ministry of Environment, Water, and Agriculture. In addition to establishing a platform for providing electronic services to farmers and investors.

Improvement of Sustainable Livestock Production

The aim of this initiative is to develop a sustainable livestock production through establishing a center to select and improve the optimum local breeds of livestock.

Study the Establishment of an Agricultural Quarantine City (Animal, Vegetarian, Fish) and the Development of the Current Quarantine System

The aim of this initiative is to develop the current quarantine system through a study to establish an agricultural quarantine city (animal, vegetable, fish) that hosts all animals and plants consignments.

Center for the Development and Production of Veterinary Vaccines for Local Infections

The aim of this initiative is to establish a vaccine production center (livestock and fisheries) for pathogens per international quality standards to cover the need for vaccines.

Establish the National Center for Marketing and Promotion of Fish Products Consumption

The aim of this initiative is to raise public awareness of healthy food by promoting the importance of seafood consumption and farmed fish products. In addition to developing the quality of exports and imports, and establishing high-quality standards to ensure fair competition for local and imported products.

The aim of this initiative is to raise the quality of Saudi dates by issuing quality certificates for the palms and dates sector as well as establishing service centers.

The aim of this initiative is to develop a comprehensive system to protect all aspects of the agricultural sector concerning the Ministry of Environment, Water, and Agriculture.

The aim of this initiative is to conduct an integrated feasibility study to establish a large aquaculture company that will increase production.

Enhance Desalinated Water Resources

The objective of this initiative is to raise the production capacity of the Saline Water Conversion Corporation by establishing, replacing, and reconstructing desalination plants and water transport lines between cities; it will thereby increase the daily produced quantities of desalinated water.

Deliver Drinking Water to Consumers

This initiative aims to expand water delivery services by increasing coverage to meet water drinking needs and accommodate the population growth.

Provide Sanitation Services

This initiative aims to expand sanitation services and increase coverage to reduce environmental damages and keep pace with the urban growth.

Reuse Wastewater

The aim of this initiative is to expand the reuse of treated water to conserve water resources through both rehabilitating treated water pump stations and establishing distribution networks.

Increase Digital Content to Improve Customer Services

The aim of this initiative is to improve the level of services offered to customers in the water and wastewater sectors by improving and developing a digital infrastructure, including e-networks and applications related to customer service.

Enhance Surface-Water Sources from Dams and Rainwater Harvesting

The objective of this initiative is to enhance surface-water resources by providing accurate information through a project to determine the water reserves in the existing and the future drinking water wells.

Reduce Water Losses in Water Networks

The aim of this initiative is to conserve water resources by detecting and treating leaks in water networks . Additionally, the initiative also aims to reduce actual losses through maximizing the utilization of existing assets such as water distribution reservoirs and household meters.

Reinforce Groundwater Sources from Wells

The aim of this initiative is to provide drinking water from underground water sources by drilling wells, extending network pipes, establishing pumping stations, and building purification plants to cope with the growing demand.

Increase Efficiency and Performance

The objective of this initiative is to increase operational and capital efficiency through the implementation of programs to enable the capacity of the Saline Water Conversion Corporation to meet the water needs and increase the opportunities for attracting investments.

Increase Participation of the Private Sector in Wastewater Treatment Plants Projects

This initiative aims to maximize the benefit of the private sector participation by privatizing 17 wastewater treatment plants along with the distribution sector. This is to improve the operational aspect, the environmental aspect and the quality of life in the cities.

This initiative aims to meet the needs of drinking water and irrigation of the Badia (Desert) by drilling wells on the boarders and remote areas.

Expand Programs to Rationalize Individual Daily Water Consumption

The aim of this initiative is to rationalize water consumption by raising the awareness of the community through several activities and benchmarking standards for all sanitary and water components.

Increase the Capacity of Strategic Water Reserves

This initiative aims at the integrated linking of all desalinated water transportation systems through establishing a network in accordance to specialized strategic studies.

Increase the Utilization of Dam Water for Agricultural Purposes

The aim of this initiative is to increase the utilization of dam water for agricultural purposes by establishing irrigation networks and channels on dams, to sustain water and contribute to the regional development.

Develop Groundwater Resources

The aim of this initiative is to promote the integrated management of water security by injecting surplus non-renewable water and treated wastewater into storage wells for use during emergencies.

Reduce Water Consumption for Agricultural Purposes

The aim of this initiative is to reduce the consumption of non-renewable water for agricultural purposes through the implementation of various projects. In addition, the initiative also aims to raise the efficiency of irrigation and calculate the agricultural consumption by analyzing satellite images.

Create a Ranking Index of Government Channels

The initiative aims to create transparency and competitiveness among government entities on how to effectively communicate with citizens and businesses by creating a benchmark to measure the effectiveness and participation of all government channels.

Build a Comprehensive Strategy for Government Communication Channels with Citizens and Businesses

The initiative aims to build a comprehensive strategy for communication channels—including local and international standards, implementation and follow-up mechanisms, and a plan of action to consolidate the points of communication—as well as to develop and activate crisis management programs within government entities.

Design an Incentive Program to Attract the Public to Government Communication Channels

The initiative aims to raise citizens' satisfaction with government agencies, and increase efficiency and transparency in communication by motivating citizens to communicate effectively with government entities.

Communicate to Enhance Trust and Raise Awareness with the Business Community

The initiative aims to raise the awareness of consumers and traders about the systems, rights, and obligations of the trade and investment system; work with partners to improve the local and international image of the private sector; and strengthen private sector links with the public sector.

Enhance Customer Experience

This initiative aims to increase the efficiency of the customer communication process through the service delivery channels, by developing operational models, procedures, and information systems to create a distinctive customer experience.

Launch and Run a Defective Products Recall Center

This initiative aims to prepare a center to recall defective products, develop a website to provide interactive services to consumers and merchants launch marketing and awareness campaigns to inform consumers of their rights in recall campaigns, and invite participation.

Develop e-Participation Communication Channels to Handle Customer Comments and Complaints, and a Platform to Follow up on Government Entities' Responses and Responsiveness

This initiative aims to launch a platform for unified e-participation: it will develop communication channels between government entities to receive feedback from their customers, and monitor the progress of government entities' responses and responsiveness.

Establish a Functional Role Responsible for Following up and Analyzing the Quality and Speed of Government Entities' Responsiveness to Customer Feedback

The initiative aims to establish a functional role responsible for monitoring and analyzing the quality and speed of the government entities' response to customer feedback and capacity development. It will undertake the necessary procedures to ensure that stakeholders comply with the Service Level Agreement as well as define the function's operational model, including organizational structure and governance model.

Implement Effective Governance and Common Standards for e-Government and Enable User Experience Improvement

The initiative aims to lay the foundations for facilitating and empowering the e-Government effectively by standardizing government entities; activating the role of IT Director within government entities; publishing and updating legislation, policies and standards; and launching awareness campaigns for the concept of effective e-government.

Rationalize Government Spending and Avoid Duplication of Investment in IT

The initiative aims to reduce government spending and achieve savings by unifying the government procurement process, activating the unified use of platforms and infrastructure, and supporting the development of programs and projects leading to long-term cost reduction.

Develop and Activate Comprehensive and Open Government Platforms

The initiative aims to develop innovative concepts of integrated government by establishing a user-centric digital user experience center, build platforms to deliver seamless services through comprehensive channels, and launch awareness campaigns for the concept of integrated government.

Summary

The Sixth Theme seeks to overcome the obstacles that development of the labor market faces for all segments of society. That will include strengthening the culture of women’s participation in the labor market, and providing the possible means that makes the working environment suitable for women. As well, through establishing supporting programs for rehabilitation and employment of people with disabilities and legislate institutional regulation that makes the working environment suitable for them which ensures their integration in the labor market. It also aims at developing mechanisms for inspection and settlement of global differences which improves people’s experiences and contributes to attracting talents.

Sixth Theme Major Challenges

- Limited tools to empower the less active segments of society in the labor market
- Limited awareness of the positive role of women in the labor market and their contribution to economic development and improvement of the GDP
- Limited training and development programs to enable females in the professional field
- Weak representation of women in leadership positions
- Poor commitment of some establishments to work regulations
- Length of procedures for the settlement of labor disputes
- The extent of the needs and challenges faced by people with disabilities cannot be accurately identified, due to a nonexistence of the definition of disability and the lack of a standardized and unified database of people with disabilities
- Poor awareness of some issues related to the work of people with disabilities, and the obstacles they face
- Most work environments are not adapted to people with disabilities
- Lack of awareness among some expatriate workers of their rights

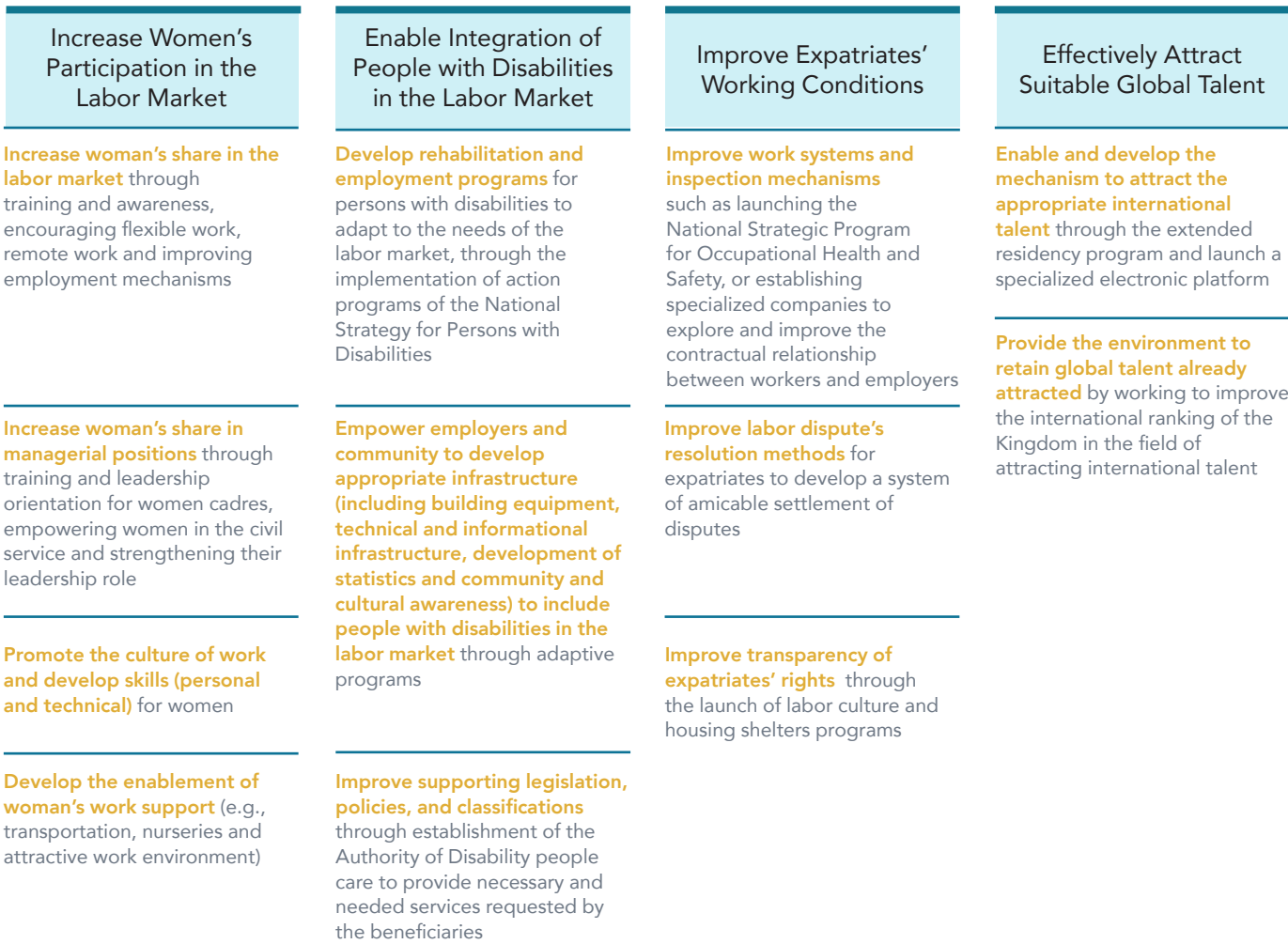

The initiative aims to implement an effective wage management system to increase transparency and secure protection for expatriates, to establish a payroll monitoring company, and protect the rights of employees and employers.

Establish a Compliance (Imtithal) Company for Inspection
